Just over a year ago, the Parish Council was reformed after all previous councillors resigned simultaneously. The current members volunteered to ensure that village administration remained within the Parish and was not managed by an external body.

I would like to express my sincere gratitude to Jenny for her dedicated work on behalf of the parish council. Her knowledge and expertise have significantly eased the challenges we faced this past year.

The village community website contains detailed information about the Parish Council, available under the Parish Council tab. The Parish Council aims to ensure transparency for all Aldbrough parishioners. Therefore, the website includes minutes of meetings, financial reports, key documents, consultation papers, to-do lists, and archived materials.

Financial Information

As discussed in last May's Parish meeting, the Parish Council's expenditures have exceeded its income for several years. This has eliminated contingency funds for emergencies or urgent works. With rising costs, this situation was unsustainable, leading to a shortfall in income to cover financial and legal commitments such as grass cutting, the Clerk's salary, liability insurance, arborist inspections, tree maintenance, and village clock maintenance. Before last November's meeting, we posted a notice on the village board and Facebook page to inform parishioners about the discussion on the village precept increase and its alternatives, inviting those interested to attend. During the meeting, it was agreed that the Parish Council would request an increase in the precept to £6700 for the year 2025/26, up from £4499 for the year 2024/25. This adjustment represents an approximate increase of 20 pence per week, or £10.40 per year, for a Band D property. This increase is intended to ensure that the precept sufficiently covers the day-to-day operational costs of the Parish Council.

It was observed that the Parish Council had previously received an annual wayleave fee from Northern Power Grid for several electricity poles erected on the village green. However, these payments had ceased some time ago. Although the amount was not substantial, it was deemed worthwhile to pursue this matter. Consequently, we received a cheque for £233.90, with an agreed annual fee of £47.00 per year.

Additionally, we engaged with Open Reach regarding their equipment and cables located on and beneath the village green. After several months of negotiations, they acknowledged that a wayleave payment was due to the Parish Council for the use of the village greens for siting their equipment. They agreed to a one-time payment of £7,602.29.

As a result, the Parish Council's finances are now in a much healthier position, enabling us to maintain a contingency fund for extraordinary events that may occur within the Parish boundaries requiring financial support. For instance, we can now fund necessary tree work that falls outside the councillors' expertise and requires the services of a professional arborist.

Money in the Bank

The PC manages two bank accounts. The NAT WEST account handles general parish expenses and income, such as precept and encroachment fees, and pays for expenses like grass cutting and insurance.

The CO-OP account is specifically allocated for the maintenance, repairs, and inspections of the play park. The funds, originally raised through fundraising efforts, donations, and grants to replace the original play park, are strictly designated for this purpose. This allocation has been agreed upon by the play park fundraising committee and must not be used for any other purposes.
